NOTICE TO EXHIBITORS

1. Events are held under the Rules and Regulations of the United Kennel Club, Inc.
2. Absolutely no alcoholic beverages or illegal drugs will be allowed on the grounds or in the buildings on the day of a U.K.C. licensed event.
3. The "No Smoking" rule will be strictly enforced in all buildings.
4. U.K.C., Tulsa Agility Club, and their agents assume no responsibility for any loss, damage, or injury sustained by spectators or by exhibitors and handlers, or to any of their dogs or property, and further assume no responsibility to children not under the control of their parents or guardians. Tulsa Agility Club is not responsible for any loss, accidents or theft occurring at the show site.
5. Exhibitors and dog owners are expected and required to clean up after their dogs. All dogs are required to be on lead on the trial grounds. Any person witnessing a violation of these rules should report it to the event committee. The event committee may ask anyone violating these rules to leave the event grounds. No refunds will be given if an exhibitor is asked to leave the grounds, and suspension from further events may result.
6. Dogs may arrive any time prior to their scheduled time of judging.
7. Move-ups may be made up to one half hour prior to the judging of the class with the approval of the trial secretary.
8. Dogs may not be left unattended in unlatched or unzipped crates. **No x-pens allowed unless they contain multiple dogs.**

ENTRY ELIGIBILITY

1. Dogs must be permanently registered with the U.K.C., have a Temporary Listing (TL) number, or have a Limited Privilege (LP) listing number prior to the closing date in order to enter.
2. Any dog having a title in another registry must show in the B class at that level. Judges and trainers must also show in B.
