# Announcements

## **Rules to Live By**

1. No dog will enter the TDTC premises without leash and handler connected.
2. No dog will exercise in the side yards without supervision by a human.
3. Dogs' human will pick up after dog eliminates.
4. Human will pick up after him/herself.
5. Human will cover my crate if I am crate aggressive (I don't want to scare any new dogs).
6. There will be no posting on front and side doors. For announcements use the information boards.

## **Building Key Applications**

As per TDTC standing rules, the following requirements must be met to obtain a key and code to the building:

Criteria for Regular Members wanting to purchase keys:

- a) Regular members are eligible to apply for a building key or associate members may apply if they have accumulated 12 points and have been actively training for 1 year or more at TDTC (2 sessions a year).
- b) Must be actively training in puppy, obedience, rally or agility classes at TDTC. (2 sessions a year).
- c) Members shall present a Key Request form with money or check attached (\$3.00) to the second VP, who shall bring the request to the Board; the Board shall have 90 days to reply.

## **NEEDED PUP INSTRUCTORS**

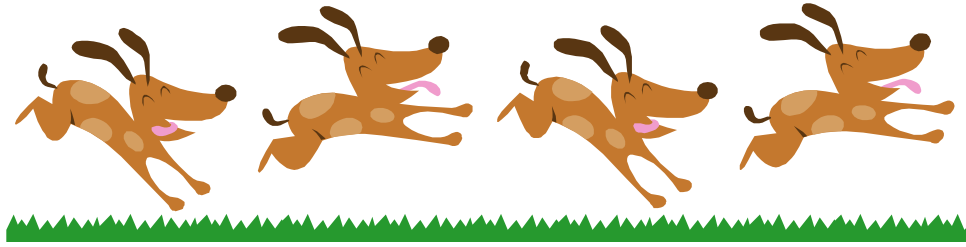
